Temporary Night Shift Supervisor

The United Counties of Stormont, Dundas and Glengarry (SDG) is located along the St. Lawrence River in the south-eastern corner of Ontario. SDG is "Where Ontario Began", and is rich in heritage, tradition, and culture with an abundance of historical sites, great events, and beautiful attractions. With a population of 65,000, SDG is primarily rural yet close to urban centres such as Cornwall, Ottawa, and Brockville.

The County is presently accepting applications for the position of **Temporary Night Shift Supervisor**. This position oversees all night-shift Truck Drivers to ensure that County Roads are maintained to required standards. This temporary position is during the winter season from approximately mid-November to mid-April. You will be required to work in a job sharing environment and a shift rotation that includes weekends.

Main duties include but are not limited to:

- Coordinate and oversee all nightshift truck drivers, both permanent and casual with the ability to supervise in a unionized environment during the winter season (mid-November to mid-April).
- Maintain road surfaces and right-of-ways in patrol areas to required standards (e.g. O. Reg. 239).
- Track weather patterns and storm events, and with this data provide direction and supervision to the patrol staff with respect to winter night shift control activities.
- Direct and maintain County and contracted snow plows.
- Coordinate and document work of external contractors as needed for snowplowing, snow removal and other maintenance activities.
- Ensure circle checks are completed on equipment prior to use.
- Monitor the 24-hour Emergency phone.
- Ensure accurate and timely completion of required documentation.

Qualifications: Post secondary education in Engineering/Public Works or related field and/or a combination of education and experience. Five years' experience in road maintenance and construction in a supervisory role (specifically with winter control procedures and practices) preferred. Ability to supervise in a unionized environment. Sound working knowledge of the *Occupational Health & Safety Act, Employment Standards Act,* collective agreements, etc. Ability to exercise good judgement and tact when dealing with staff, contractors and the public. Possess and maintain a valid G driver's license.

Salary Range: \$34.05 to \$38.91/hour, plus applicable statutory benefits

Schedule: Averaging 70 hours bi-weekly

Duration: Mid-November to Mid-April for an approximate 21-week term
