

## The Next Play – Grant Opportunity for Ontario Sport Organizations

interested in creating opportunities in sport for women and girls

Canadian Women & Sport invites sport, physical activity and recreation organizations across Ontario to apply for The Next Play, a grant program aimed at creating sport and active recreation opportunities for girls and gender-diverse youth. This project is made possible by the Government of Ontario.

Recent information from the **Rally Report** show that girls and women face many barriers to fully participating in active recreation. Meanwhile, there is immense pressure on sport leaders and organizations to better engage girls and gender-diverse participants.

The Next Play aims to address these challenges by empowering sport leaders from 50 Ontario-based organizations with the tools and resources they need to design sport opportunities with girls and gender-diverse youth in mind.

As part of The Next Play:

- Sport leaders will receive training on how to better design sport and active recreation experiences for girls and gender-diverse participants.
   Participating organizations will receive a \$1,000 honorarium to support with this training.
- Participating organizations will develop and submit a project proposal outlining their plans for better engaging and retaining girls and genderdiverse youth in active recreation in their communities. Proposals should reflect the unique needs of their communities and organizations, and learnings from the program design training. Organizations with successful completed proposals will receive a \$4,500 grant to support their initiatives.
- Participating organizations will start active recreation initiatives in May 2024 and complete final reporting by August 31, 2024.


Who is The Next Play for?

The Next Play is for Ontario-based active recreation organizations that are eager and ready to engage more girls and gender-diverse participants from diverse backgrounds. Active recreation includes sport and physical activity programs as well as cultural and game-based programming.

Applications open on Friday, March 8, 2024, and close on Monday, April 1, 2024 at 5:00 PM Eastern Time.

# Unemployment rate edges higher despite job growth

"Canada's labour market is on track for decent job growth in the first quarter, but the headline number isn't the whole story. With a declining employment rate, the economy is unable to absorb a fast-rising population into the workforce. The sectors that are growing in recent months have been as a result of labour actions or gaining back the workers who left the industry and who face acute shortages, like accommodation and food services. There were some good numbers as hours worked rose 0.3% on the month, which is a signal that the first quarter is maintaining momentum from the fourth quarter. A further normalization of wages, moderating to 5% growth in February, is also welcome news, trending in the right direction to ease core inflationary pressures."

# Apply now for the Grow Ontario Market Initiative



Learn how to apply for funding to grow your agri-food business through marketing analysis and planning, new product development and marketing activities.

The Governments of Canada and Ontario are investing up to \$12 million in market development efforts under the Sustainable Canadian Agricultural Partnership (Sustainable CAP) to help eligible agri-food businesses and industry organizations expand into domestic and foreign markets.

The **Grow Ontario Market Initiative** is a new, cost-share initiative that helps food and beverage processors, farm businesses and agri-food sector organizations take actions to reach new markets. Examples of eligible projects could include:

- Market analysis and planning
- · Product development activities
- New market-entry promotional efforts to expand opportunities for Ontario food products

Under the **Grow Ontario Market Initiative**, applicants can receive up to 50 percent cost share for eligible costs, to a maximum of \$60,000 per business for producers and food and beverage processors, and up to \$125,000 for sector organizations. Eligible businesses can apply for support through this program that opened on May 19, 2023.

## Understandimg trade accelerators: Facilitate your international journey

Trade accelerators are designed to fast-track the growth of companies at various stages of their international journey. They focus on speeding up the process of entering new markets and expanding international business activities. Key aspects of these specialized programs include:

- Market-entry support
- Networking opportunities
- Introductions to potential partners, investors, and more
- Educational resources
- Access to funding opportunities
- Potential government and institutional partnerships

Companies starting their export journey can join one of the Trade Accelerator Program (TAP) sessions, which are supported by the Trade Commissioner Service and organized in collaboration with local chambers of commerce in cities like Vancouver, Calgary, Toronto, Montreal, and Halifax.

This program, co-sponsored by government organizations such as Export Development Canada, in partnership with the Royal Bank of Canada (RBC), is a launchpad for companies aiming to develop strong export plans.





My Main Street is being delivered by the Canadian Urban Institute offering two streams that open for applications on February 22, 2024.

The Business Sustainability stream provides up to \$20,000 directly to businesses for productivity enhancements. Funding will be made available to businesses that employ between 1 and 50 staff, have demonstrated revenue growth, and provide a business case on how the funding will strengthen their existing capacity and support their growth.

The Business Sustainability stream is open for applications between February 22 and March 31, 2024.




# Federal Alcohol Excise Tax capped at 2% until 2026



On March 9th, Federal Finance Minister Chrystia Freeland announced that the federal government will be extending a cap of 2% on the annual alcohol excise tax for beer, spirits, and wine for an additional two years. Initially scheduled to increase by 4.7% tied to inflation on April 1st, the tax hike will now be limited to the lower rate. Additionally, the Minister unveiled tax relief measures for local craft breweries, slashing the excise duty rate on the first 15,000 hectolitres of beer in half for a two-year period.
